

## WHAT IS A PRIVATE ORGANIZATION?

#### What is a Private Organization (PO)?

 POs are one type of non-federal entity. They are set up by people acting exclusively outside the scope of any official capacity as officers, employees, or agents of the Federal Government.

Basically: not owned or operated by the federal government but often made up of federal government employees.



## WHAT IS A FOR US BY US ACTIVITY?

What is a For Us By Us Activity (FUBU)?

- Federal employees acting within their official capacity to fundraise among their own members, for the benefit of their own members or dependents.
- Ex. farewells, unit holiday parties, helping with personal misfortune etc.
- Private Orgs are <u>NOT</u> For Us, By Us entities



## **Operating a Private Org**

- Private Orgs must have:
  - Constitution and Bylaws
    - Must have CERTIFICATION that PO members were notified and

understand their personal liability

- Insurance <u>or</u> Insurance waiver signed by <u>all members</u>'
- Budget and financial statement



## **Operating a Private Org**

- Insurance Waiver
  - Must be renewed annually
  - Legal Review with Constitution and By-Laws



## **Operating a Private Org**

- Meeting minutes quarterly
- Point of contact list annually or every board turnover
- A valid Tax ID or Tax Exempt Number
  - (Confirm with IRS periodically)
- Attend annual JA and 50 FSS training



## PRIVATE ORG DO's and DON'Ts

## Operating on-installation or off-installation?





When on-base, PO can:

- Host fundraisers
- Maintain any amount of funds (conditions apply)
- Raise funds outside their unit (but away from "workplace")



**PRIVATE ORG DO's** 

POs with certain levels of gross annual revenue must undergo audits and financial reviews at PO's own expense (section 10.7)

- \$5,000 \$100,000 (no audit, but yearly statement)
- **\$100,000 \$250,000 (Accountant CPA not needed)**
- \$250,000 or more (CPA must perform audit)



**PRIVATE ORG DO's** 

 Must display disclaimer on all print and electronic media (AFI 34-223, para. 10.1.2.3):

THIS IS A PRIVATE ORGANIZATION. IT IS NOT A PART OF THE DEPARTMENT OF DEFENSE OR ANY OF ITS COMPONENTS AND IT HAS NO GOVERNMENTAL STATUS.



**PRIVATE ORG DON'Ts** 

When on base, PO cannot:

- Fundraise in uniform
- Fundraise in the 'workplace' (desk-desk)
- Solicit from anyone at anytime on installation
- Use AF email or channels to advertise events
- Host more than three fundraisers per calendar quarter





## POs must not duplicate or compete with AAFES or Service NAFIs







- PO may not sell or serve alcoholic beverages on base (AFI 34-223 Section 10.14)
- PO will not operate amusement machines, slot machines, or any other games of chance (except as provided for in AFI 34-223, 10.20)



**PRIVATE ORG DON'Ts** 

When off base, POs cannot:

- Wear uniform of official military attire during fundraisers
- Cannot use posters without the disclaimer
- Violate the laws of the state in which they operate



For Us By Us (FUBU)

**Unlike Private Orgs, FUBUs can:** 

- Be organized by the unit level command
- Have their fundraising efforts be advertised and supported by the command
- Advertise events to the unit using official channels, such as work email
- Do all the above while on duty, if the mission allows





#### When on-base, FUBUs can:

- Fundraise within their unit (primarily)
- Request money from unit members only (<\$10)</li>
- Solicit money in the 'workplace'



For Us By Us (FUBU)

#### When off-base, FUBU's can:

 DO NOTHING! FUBUs are considered 'federal entities' and therefore not permitted to conduct fundraisers off the installation or solicit gift from outside sources.



## PO v. FUBU

#### <u>PO:</u>

- 1. Servicemembers +
- 2. Members acting in personal

capacity

- 3. Cannot fundraise in uniform
- 4. Cannot fundraise in workplace
- 5. Cannot solicit on base

#### FUBU:

- 1. Servicemembers +
- 2. Members acting in official capacity
- 3. Can fundraise in uniform
- 4. Can fundraise in workplace but

largely limited to unit members

5. Can solicit from unit members





#### Private Org:

6. Cannot use official channels to

advertise

- 7. Can raise and hold any amount
- 8. Can fundraise off base

#### FUBU:

6. Can use official channels but

only to unit members

- 7. Cannot hold > \$1000
- 8. Cannot fundraise off base



#### UNOFFICIAL UNIT-AFFILIATED ACTIVITIES

- Examples: water funds, coffee funds, sunshine funds
- Not PO UNLESS
  - Current assets exceed monthly average of \$1,000 over a three month period (do not count on-hand inventory in current asset calculation)
- If activities exceed asset limit of \$1,000 then must become recognized as PO, discontinue operations, or reduce current asset level to below \$1,000



#### UNOFFICIAL UNIT-AFFILIATED ACTIVITIES

#### Exception to asset limit:

- UUA can temporarily exceed asset limit for a time period no longer than six months if substantial majority (more than 75%) of assets will be expended on upcoming large event
  - E.g. holiday party, military ball, etc
- Average monthly limit of \$1,000 can be increased by \$100 for every 50 unit members over 300 members – maximum of \$5,000 monthly average



#### UNOFFICIAL UNIT-AFFILIATED ACTIVITIES - ACCOUNTING

- UUAs not required to implement financial management tools
- UUAs, at a minimum, must implement financial controls
  - Maintain a two person accountability system for all cash transactions
  - Submit a basic annual financial report to the unit commander detailing income and expenditures throughout the year



#### AF ASSISTANCE FUND AND COMBINED FEDERAL CAMPAIGN

#### No fundraising during the CFC and AFAF

#### **Exception:** Fundraising for Unit Holiday Party



## DISSOLVING A PRIVATE ORGANIZATION

# GOING OUT OF BUSINESS **EVERYTHING MUST GO!**



**DISSOLVING A PO** 

 Must use funds to satisfy outstanding debts, liabilities, or obligations (Section 12)

 Dispose of the residual balance as decided by the PO membership

 Notify FSS of intent to dissolve PO and prepare time-phased action plan to do so



**DISSOLVING A PO** 

 If becoming a FUBU, then must adhere to all FUBU rules (max \$1000 funds, cannot fundraise off base).

 Failure to comply means the FUBU will have to return to Private Org status.
